

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://offscrip.com>, and OffScrip Health, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to OffScrip Health, Inc. include <https://offscrip.com> and OffScrip. The OffScrip website is a digital audio production and distribution site. By using the OffScrip website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, OffScrip may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

OffScrip may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race
- Religion
- Political Affiliation
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

OffScrip collects and uses your personal information to operate and deliver the services you have requested.

OffScrip may also use your personally identifiable information to inform you of other products or services available from OffScrip and its affiliates.

Sharing Information with Third Parties

OffScrip may sell, rent, or lease customer information to third parties for the following reasons:

If permission is granted by the user to do so, we may provide user information to public or private third parties that are in a position to provide a service or a product the user may find valuable.

OffScrip may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. OffScrip may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to OffScrip, and they are required to maintain the confidentiality of your information.

Opt-Out of Sale or Disclosure of Personal Information to Third Parties

In connection with any personal information we may sell or disclose to a third party for a business purpose, you have the right to know:

- The categories of personal information about you that we sold and the categories of third parties to whom the personal information was sold; and
- The categories of personal information that we disclosed about you for a business purpose.

You have the right under the California Consumer Privacy Act of 2018 (CCPA) and certain other privacy and data protection laws, as applicable, to opt-out of the sale or disclosure of your personal information. If you exercise your right to opt-out of the sale or disclosure of your personal information, we will refrain from selling or disclosing your personal information, unless you subsequently provide express authorization for the sale or disclosure of your personal information. Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by OffScrip. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the OffScrip website.

Use of Cookies

The OffScrip website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

- SSL Protocol
